 - a. Membership
 - i. Report on response to membership campaign: need-processing of beds, please sign up by Feb, membership meeting moved up, trying to enforce deadline of renewal may be difficult. Can we share the load of signing up/reminding/making personal contact with last

years members starting 3/2. Mentor solicitation: social people - 2-3 people; mentor would be given with the bed; guidelines will be made (2 workdays missing -mentor reach out; weeds -would you like to meet to work together) Mentors will be recruited.

- b. Kelly Green Project: Awarded design grant from PWD for engineering firm to do a study and design an overhaul to do stormwater management, Camille in classrooms with grow lights, growing wheatgrass. Checking account on its way,
- c. Fundraising: Food Fit Philly proposals (Camille and Shelah): Camille contacted Enon Church about several vacant lots. Idea: 2 lots would become farms that would have food sold as CSA and donated to food pantry. Final proposal: turn vacant lots into urban farms, Our proposal: map food purveyors in area soup kitchens, food pantries, corner markets (do they carry fruit, veg), try to get them on board to supply healthier options, map vacant lots in area, growing food, community education, school education sell some produce locally
